NOTIFICATION

The 12th October 1989

No. 17/28- ES (Estt.) –II-39/89-(Pt.)P.-In exercise of the powers conferred by the Proviso to Article 309 of the Constitution of India, the Governor of Orissa hereby makes the following rules further to amend the Orissa Statistics and Economics Service Rules, 1979, namely:-

(1) These Rules may be called the Orissa Statistics and Economics Service (Amendment) Rules 1989.

(2) They shall come into force on the date of their publication in the *Orissa Gazette*

2. In the Orissa Statistics and Economics Service Rules, 1979, (hereinafter referred to as the said Rules) in Rule-2, for clause (a) the following clause shall be substituted, namely:-

(a) **“Directorate”** means the “Directorate of Economics and Statistics”.

3. In the said Rules, in rule 3, for sub-rules (2) and (3) the following sub-rules shall be substituted, namely:-

(2) The Orissa Statistics and Economics Service Class-I shall include the posts of Joint Director Level-I, Joint Director Level-II, Principal. Statistical Training Institute and Deputy Director in the Directorate of Economics ad Statistics and such other post or posts as Government may from time to time specify in this behalf.

(3) The Orissa Statistics and Economics Service Class-II shall include the posts of Assistant Director, District Statistical Officer and Additional District Statistical Officer under the Directorate of Economics and Statistics, post or posts in respective ranks in other departments, posts of Assistant Director and Research Officer of the Planning & Co-ordination Department of Government of Orissa which existed prior to the 29th January 1979, the date on the which the Planning & Co-ordination Department was reorganized and formed part of the then Evaluation Cell of the said Department and such other post or posts as Government may from time to time specify in this behalf.

4. In the said rules, for rule 5, the following rule shall be substituted, namely:-

(1) There shall be constituted a Departmental Promotion Committee for selection of Officers for promotion to Class-II and Class-I posts in the Orissa Statistics and Economics Service.

(2) The Departmental Promotion Committee shall consist of:-

(a) Additional Development Commissioner and Secretary to P & C. Department. .. Chairman

(b) Special Secretary/ Additional Secretary to Government, P & C Department. .. Member

© Director, Economics and Statistics, Orissa .. Member

(d) Joint Secretary/Deputy Secretary to Government in P & C Department in-charge of Gazetted establishment of the Directorate of Economics and Statistics. Member Secretary

(3) The Committee so constituted shall meet as and when required for selection of officers for promotion to the respective class and posts.

5. In the said rules, for rule 6, sub-rules (1) and (2) the following shall be substituted, namely:-

(1) Recruitment to the posts of Joint Director Level-I shall ordinarily be made by promotion from amongst the officers holding the post of Joint Director Level-II, recruitment to post of Joint Director Level-II shall ordinarily be made by promotion from amongst the officers holding the post of Deputy Director who have completed at least four years of service as such on the 1st day of August of the year in which the vacancy arise:

(2) Recruitment to all other posts in the Orissa Statistics and Economics Service Class-I shall ordinarily be made by promotion from amongst the officers holding the posts or Assistant, Director, District Statistical Officer or other equivalent posts who have completed at least four years of service on the first day of August of the year in which the vacancy arises.

6. In the said rules, in rule 7 for sub-rules (1), (2) and (3) the following sub-rules shall be substituted namely:-

- (1) On a vacancy arising in the post of Joint Director Level-I, Joint Director Level-II, Principal Statistical training Institute, Deputy Director or any equivalent post, names of eligible persons to be taken into consideration for promotion to such posts in accordance's with rule 6, shall be 3 times the number of vacancies, in the list of such persons arranged in order of seniority. The seniority list of officers along with the select list of Departmental Promotion Committee shall be forwarded to the Commission along with service records and C.C. Rolls for recommendation by the Commission of names of officers for filling up the vacancy as the case may be.
- (2) The Commission shall consider the list along with documents received from the Government and recommend to Government a list of candidates as they consider suitable for appointment to the post or posts, the list being arranged in order of merit as would be determined by the Commission.
- (3) The selection of officers for promotion shall be based on merit and suitability in all respects with due regard to seniority.

7. In the said rules, the sub-Rule 6 of rule 7 shall be deleted.

8. In the said rules, Rule 8 shall be deleted

9. In the said rules in rule 13, for sub-rule (2) the following sub-rules, shall be substituted, namely:-

- (a) for direct recruitment and promotion in respect of candidates belonging to the Scheduled Castes and Scheduled Tribe, the procedure prescribed in Orissa Reservation of vacancies in Posts and Services (for Scheduled Castes and Scheduled Tribes) Act, 1975 and the rules made there under shall be followed.
- (b) for direct recruitment to the service, Class-II for ex-servicemen, sportsmen and physically handicapped persons. Procedure as may be prescribed by the Government from time to time shall be followed.

10. In the said rules, in rule 21 for sub-rule (a), the following sub-rule shall be substituted, namely:-

- (a) Officers appointed to the Service by promotion shall be ranked *inter se* in the order as would be finally decided by Government under-rule 7 (4)

11. In the said rules, in rule 22, for sub-rules (1) and (2), the following shall be substituted, namely:-

- (1) Government may hold a Departmental Examination for persons appointed to the service under rules 17 and 18 and the subjects of such examination, the syllabus therefore, the maximum marks for each subject, the minimum marks in each subject to be secured for the purpose of passing of the said examination shall be set out here-in-after.
- (2) The failure to pass the Departmental Examination within a maximum of 4 chances available after the joining of officers in service shall result in with holding their promotion and increment due after availing of the 4th chance:

Provided that if a departmental examination is held within six months of the joining of the officer in-service and the opportunity to sit in the examination is not availed by him, it would not be counted as a chance:

Provided further that if the candidate passes the departmental examination in any subsequent chance he shall be allowed the pay which he would ordinarily have drawn had he passed the said examination within the prescribed number of chances but shall not be entitled to any amount on account of the increments with-held.

12. In the said rules, for rule 23, the following rule shall be substituted, namely:-

(1) There shall be constituted a Board of Examiners (hereinafter referred to as the Board) consisting of-

- (a) The Secretary to Government, Planning & Co-ordination Department;
 - (b) Special Secretary or Additional Secretary in the Planning & Co-ordination Department to be nominated by Government;
 - (c) The Director, Directorate of Economics and Statistics;
 - (d) Principal, Statistical Training Institute
- (2) Government may also nominate two other persons having knowledge in Statistics and/ or Economics as members of the Board.
 - (3) The Secretary to Government, Planning & Co-ordination Department shall act as the Chairman of the Board and shall preside over its meeting.
 - (4) The Principal, Statistical Training Institute under the Directorate of Economics and Statistics shall act as *ex officio* Member-Secretary of the Board.

13. In the said rules, for rule 31, the following rule shall be substituted, namely:-

- (1) A probationer shall be deemed to have passed the examination in any subject if he secures at least 60 per cent of the marks in the said subject.
- (2) A probationer may pass the examination in parts:

Provided that he shall not be deemed to have passed the examination unless he has passed in all the subject prescribed for the departmental examination.
