Sub:- Implementation of Infrastructure Development Project upto Rs.50.00 lakh per Assembly Constituency under the "Special Development Programme, 2012-13".

Madam/ Sir,

I am directed to say that with a view to expediting infrastructure development, Government have been pleased to sanction funds to the extent of Rs. 50.00 lakh (Rupees fifty lakh only) per Assembly Constituency under the Special Development Programme for the year 2012-13. The proposed infrastructure projects shall include culverts, cause ways, small bridges, check dams, rural and urban roads, anganwadi centres, drinking water supply projects including tube wells as well as piped water supply projects and such other critical infrastructure that fulfills the felt needs of the local people.

2. Infrastructure projects in each Assembly Constituency shall be identified by the concerned MLAs and shall be sent to concerned Collectors for approval and further follow up action. Each project should have a minimum outlay of Rs.5.00 lakh and each road project should be either concrete cement (CC) or bituminous (BT) road.

3. Pending finalization of the guidelines for the "Special Development Programme", the procedures and guidelines as applicable in case of MLALAD fund shall be followed as far as the proposals under Special Development Programme are concerned.






