Sub: Constitution of Sub Committee for monthly review of RIDF projects implemented in Odisha

The Rural Infrastructure Development Fund (RIDF) has been instituted by the Govt. of India since 1995-96 under National Bank for Agriculture and Rural Development (NABARD) with a view to strengthen the infrastructure base of rural area the State. The activities generally covered under RIDF in recent years are Rural Roads, Bridges, Major & Medium and Minor Irrigation, Flood Protection, Drainage, Market Yard, Fishing Harbour, Animal Husbandry etc.

2. After careful consideration, the High Power Committee held under the Chairmanship of DC-cum-ACS has been pleased to constitute a Sub-Committee for review of Progress of RIDF Projects, examine the preparedness of the Projects to be posed for HPC approval, submission of claims by Departments, and constraints and bottlenecks in implementation of projects.

4. **The Terms of Reference (TOR) for the Sub Committee**

- a) The Sub Committee shall review the progress of RIDF projects including submission of claims and disbursement by NABARD.
- b) The Sub Committee shall examine the preparedness of the projects prior to their posing for HPC approval.
- c) The Sub Committee shall oversee the adherence of the procedure for implementation of RIDF Projects by implementing Departments.


d) The Sub Committee shall examine the constraints /bottlenecks involved in implementation of projects and suggest remedial measures.




