RESOLUTION

The 24th December 1997

SUBJECT—Method of recruitment to the posts of Instructor in Rural Sociology & Instructor in Rural Development in Class-II of State Service in the State Institute for Rural Development (S. I. R. D.), Bhubaneswar.

The principles for recruitment to the posts of Instructor in Rural Sociology and Instructor in Rural Development in Class-II of State Services in the scale of pay of Rs. 2,000—60—2,300—E. B. —75—3,200—100—3,500 were under consideration of Government

for some time past. After careful consideration of Government have been pleased to lay down the following principles for filling up of the aforesaid posts, through the Orissa Public Service Commission as no recruitment fules have yet been framed by Government.

- (i) The appointment to the bove posts does not come under purview of Orlesa Reservation of Vacancies in posts and services (For Scheduled a Caste & Schedule Tribes).
- (ii) a Minimum qualification for the posts of Instructor in Rural Sociology is 2nd Class Master's Degree with minimum 55% of marks at Post-Graduate leval in Sociology/Rural Sociology from a recognised University.
- b. Minimum qualification for the post of Instructor in Rural Development is 2nd Class Master's Degree with 55% of marks at Post Graduate level in Rural Development/R ural Management from a recognised University.

- (iii) The candidate should possess minimum, 3 years Teaching/Research experience under any recognised Institution of the States Preference will be given to candidates having Ph. D. Degree.
- (iv) Age—The B candidates shall be under 32 years & over 21 years of age as on 1st January 1998. Age-limit may be relaxed by five years in ease of SC/ST & three years in case of women candidates.
- (v) The candidate shall be able to speak, read and write Oriya and must have passed Oriya equivalent to M. E. School standard.
- (vi) A male candidate having more than one wife living or a female candidate who is married to a person who has more than one wife living will not be eligible for appointment.
- 2. The resolution shall remain in force till Recruitment Rules in pursuance of the provision to Article 369 of the Constitution of India are framed.
- 3. The Resolution shall be given to effect to from the date of issue.
- 4. The Orissa Public Service Commission, Cuttack, Accountant-General, Orisa Bhubeneswar/Director, State Institute for Rural Development, Bhubaneswar are being informed.

- I (A) (iv) Five scholarships for girl students admitted to Indian Institutes of Technology on the basis of common admission test or Birla Institute of Technology and Science, Pilani on the basis of common selection procedure adopted therein for the first degree course in Engineering including Architecture.
