**RESOLUTION**

Estt.PM-I-64/2021

In order to strengthen the district planning apparatus, provide secretarial and technical support to the District Planning Committee (DPC), assist DPC in monitoring and evaluating the implementation of developmental programmes and prepare shelf of projects and Detailed Project Reports for development programmes, District Planning and Monitoring Units (DPMUs) have been constituted in each district. The role of Senior Economic Investigator is important in the DPMUs to analyse and evaluate the developmental programmes in DPMUs.

Since amendment to the Odisha Sub-ordinate Planning Service (Method of Recruitment and Conditions of Service of Senior Economic Investigators and Cartographers) Rules, 2015, will take time and new recruits have been appointed in the meanwhile, the State Government, after careful consideration, have been pleased to make the following provision for the training of newly recruited Senior Economic Investigators, pending formal amendment to the Odisha Sub-ordinate Planning Service (Method of Recruitment and Conditions of Service of Senior Economic Investigators and Cartographers) Rules, 2015 .

1. The new recruitee Senior Economic Investigators of Planning and Convergence Department shall be imparted Three Months Orientation Training Course during the period of Probation.
2. The curriculum of the training programme has been published vide this Department Letter No.10472/P dated 08.9.2021.
3. Formal amendment to the Odisha Sub-ordinate Planning Service (Method of Recruitment and Conditions of Service of Senior Economic Investigators and Cartographers) Rules, 2015 will follow.
4. This Resolution shall be effective from the date of issue.
