Sealed quotations in plain paper/letter head are invited by the undersigned for auction sale of Ambassador Car (Diesel) No. OR-02-X-6465, TATA INDICA (Diesel) No. OR-02-U-2662 and Ambassador Car (Diesel) OR-02-BJ-7855 under P&C Department.

The intending bidders may inspect the vehicles (OR-02-X-6465 and OR-02-U-2662) parked in the Loka Seva Bhavan premises during working days before filing quotation. The vehicle bearing No. OR-02-BJ-7855 may be inspected at M/s Harinandan Motor Works, Plot No. 667, Old Station Square, Cuttack Road, Bhubaneswar.

The sealed tender will be received upto 3.00 PM on 17.05.2022 and will be opened by the undersigned on 18.05.2022 at 4.00 PM in his office chamber in presence of the bidders or their authorized agents. If the mentioned date for opening of tenders is declared as Government Holiday, the tenders will be opened on the next working day on the scheduled time.

The highest rate quoted by the bidder above the upset price shall be accepted and confirmed. The purchaser is liable to pay GST along with cess as per applicable rate on the bid amount. The highest bidder is required to deposit 25% of offered amount of the vehicle immediately after the sale is confirmed and the rest amount within 7 days from the date of acceptance of tender. If the highest bidder fails to deposit the balance amount within above stipulated time, the deposited amount will be forfeited. The successful bidder shall have to remove the vehicle from the present premises within 7 days from the date of depositing the full amount of the tender money, failing which the Department will not be responsible for any damage, pilferage or otherwise and no claim in this regard shall be entertained by the Department. The ground rate @1% of the tender amount shall be charged for each day of delay after lapse of stipulated period till removal of the vehicle from the site. If the ground rent so charged exceeds the sale price deposited, the bidder shall cease to have any right on the vehicle and the amount deposited by him/her shall be adjusted towards ground rent.

The Upset price fixed by M.V.I., Bhubaneswar-I for the vehicle OR-02-X-6465 is Rs. 13,000/-, vehicle OR-02-U-2662 Rs. 15000/- and for the vehicle No OR-02-BJ-7855 is Rs. 13000/-. 
