Applications are invited from retired "Group - D" employees for engagement against the Group - D posts in Secretariat Establishment of P&C Department on contractual basis latest by 14.02.2023 in proforma annexed herewith along with copies of documents.

1. Number of vacancies to be filled up :- 9 (Nine)

2. Eligibility Conditions :

- I. Employees who have retired from Government Service on attaining the age of superannuation and below the age of 65 years having good service records and are physically fit shall be eligible to be considered for re-employment.
- II. Employees against whom Departmental Proceedings or Criminal cases are contemplated / pending or who have been penalized for misconduct during the period of preceding five years will not be eligible for consideration.

3. Selection Process :

Selection will be made through the Selection Committee constituted for the purpose.

4. Tenure, Terms and Condition:

- I. The re-engagement shall be made initially for a period of one year only.
- II. Re-engaged employees will be entitled to consolidated remuneration of Rs.10,000/- PM only.
- III. Re-engaged employees shall be governed by the provisions of Odisha Government Servants Conduct Rules, 1957 and shall be liable to be proceeded against for their misconduct, omissions and commissions as per the provisions under the Odisha Pension Rules, 1992.
- IV. The re-engagement can be terminated at any time by the appointing Authority due to unsatisfactory performance of any of the re-employed employee by giving one month notice. On the contrary, if any re-employed employee desires to resign he shall do so by giving one month's written notice to the competent authority.


