The **Superintending Engineer, P.H. Division, Balasore** on behalf of Governor of Odisha invites **Percentage Rate Bids** through **e-Procurement** in conformity with the terms and conditions of the Detailed Tender Call Notice (DTCN) in Single Bid system (Price Bid) from Appropriate **Class Contractors** registered with the Odisha State Government and Contractors of equivalent grade/class registered with Central Government/ any other State Government/ MES/ Railways having experience and expertise in execution of Similar Type of Works and fulfilling minimum eligibility criteria as stated hereunder and other detailed qualifying requirements given in the DTCN to be eventually drawn up in the **Standard P-1 Contract Form of Odisha PWD**. The bidders should have the necessary Portal Enrolment (with his own Digital Signature Certificate).
